- makes a claim for any loss or damage you caused deliberately or with your knowledge, or if your claim is in any way dishonest or exaggorated;

We will not pay any benefit under this policy or return any premium to you and we may cancel your policy immediately and backdate the cancellation to the date of the fraudulent claim. We may also take legal action against you and inform the appropriate authorities.
